1 GENERAL CONDITIONS

- a All fares listed are valid for travel on Singapore Airlines flights only, and must be issued in Singapore on Singapore Airlines Electronic Tickets (ET).

2 TICKETING CONDITIONS

a Reservations / Ticketing:

Waitlist reservations are not permitted. All reservations must be confirmed.

Tickets must be issued within 3 days after reservations are made or at least 3 days before departure, whichever is earlier.

Tickets must be issued by 4May2010.

b Minimum/ Maximum stay: As stipulated in the fare sheets.

c Stopovers / transfers: Not permitted.

d Permitted combinations:

- End-on end combination is not permitted.
- Turnaround open jaw is permitted as stipulated in the fare sheet. The higher return fares must be charged.

e Ex SIN Blackout Period: Fares do not apply when travel during the Blackout periods.

a) between 29 Apr 2010 to 1 May 2010 (inclusive) and 26 May 2010 to 28 May 2010 (inclusive)

These blackout periods are applicable on the outbound travel dates.

f Changes:

- Rebooking / Revalidation: Flight/Date change not permitted.
- Rerouting / Reissuance: Not permitted.

g Cancellation / Refund: Tickets once issued are non-refundable.

h Child / Infant discounts:

- Accompanied Child / Accompanied infant occupying a seat:
100% of the applicable adult fare
- Infant not occupying a seat : VE02SG not permitted
